# Theft By Any Other Name

Can you believe it, another theft by the state of New York? This time it will be an even bigger theft. Grand total of \$5 million over the next 5 years.

The office of budget claims the theft will have little effect on the operations of snowmobile clubs. It should be noted that the ill gotten funds will have very little effect on decreasing the budget deficit.

This theft is in line with other cuts and grabs that the State is taking. Many state parks have been slated to close. Even Thacher Park was on the block for closure until enough people protested. The closing of State Parks would save the State about the same



money it is stealing from snowmobilers and would have similar long term effects.

How many thousands of state programs and agencies will have to be cut to make budget? Will taking a million dollars from each solve the deficit?

The effect on the sport of snowmobiling will be huge regardless of what the Office of Budget says. Many clubs will have to curtail grooming and trail maintenance. That means fewer trails will be open or in good condition.

This in turn will equal in fewer people riding and buying goods and services in this state. Businesses will have lower revenue and the State will see reduced registration fees and sales tax coming in. Fewer visitors will be coming to this state to ride and spend money here.

Club Elections April 14th! Come to the meeting and vote, Elk's Lodge, Esperance. Less money coming in to the economy does not seem like a good idea. The State should look at how the snowmobile fund works. It does not run in the

**President's End of Season Report** This has been a challenging season for the Club; many issues came up before and during the season. Thanks to the hard work of our members, our trails were ready when the snow finally arrived.

Trail issues that were worked on over the season include the C7B reroute near Weaver Road. This trail runs through a bottle neck of sorts, it must cross I-88, Rt 7, and the railroad in one area. To accomplish this feat took many hours and contacts. New landowners were approached, property was walked, and landowner agreements signed. A way past the railroad spur was found but it needed approval from various entities at the railroad. Submission to NYS DOT for the crossing of Rt 7 was made. After approvals came in the actual trail work began, clear cutting a new trail through dense thicket, a new bridge was built and signs were put up marking the trail, all after winter had arrived.

Once the trail opened, problems arose with snowmobiles not riding where they were supposed to. Neighboring properties were being impacted negatively and this required immediate correction.

Another section of C7B required rerouting before the end of fall. A landowner had revoked our privilege to cross the property, so the trail boss began looking quickly for a new route. Fortunately he found a route which turned out to be a very good trail.

Trail grooming was carried out as soon as there was enough snow. The New Holland groomer and drag proved invaluable during the late season snow storm. Working with two skandic sleds as trail breakers, the New Holland could pack a wide flat track. This trio was able to successfully open C7B from East Berne to Benninger Road south of Delanson. The Club's fleet of skandics worked all over the trail system, breaking open the deep snow, while cutting and clearing hundreds of tree limbs from Mariaville, Burtonsville, Esperance, Delanson, Duanesburg, Knox, and East Berne.

During and after the big storm, an incredible amount of work was done by <u>Club members</u> to make the trails passable.

Our work continues at this time, the pulling of signs, closing of gates, correcting any damage to our landowner's prop-

erty. These are the basic trail duties remaining this season. Volunteering now would help the Club greatly.

We also have other things going on, NYSSA forum, the Adopt A Highway program, Club elections, tax filing, groomer financing and the end of season dinner.

Looking beyond that, we have grant deadlines approaching in May and again in August. In this time period there is a lot of paper work. It is likely our most important function for keeping the trails open. Work with our sponsors, the counties and towns, and NYS Parks is on going during the year.

Please remember that even though the groomers and snowmobiles are being put away for summer, we have a lot of things to do over the next couple of months. Stay informed and stay involved. Joel Church.

### NYSSA NEWS

A Second Call for Action from NYSSA and your President Mike Fischer:

We at NYSSA have been working with our lobbyists to take whatever actions are necessary to oppose this unwarranted sweep of our money from the trail fund and the expanded language in Part HH of Budget Bill S6609/A9709. We have been reaching out to the Legislature and asking for their help to correct this intolerable situation.

As President of NYSSA, I have gone to Albany and met with key Assembly Members, Senators and the Secretary to the Senate Finance Committee to express our opposition to the language in Part HH of Budget Bill S6609/A9709 that would expand the allowable use of monies in the snowmobile trail fund to include "public safety activities," and urge that this language be removed from the budget as well as express our opposition to this unprecedented sweep from the trail fund.

I am calling on every one of our Club Presidents and their members to fax a letter and place calls to Governor David Paterson and New York State Budget Director Robert Megna asking them to rescind the \$1 million sweep of the Snow-mobile Trail Fund and to remove the language in Part HH of Budget Bill S6609/A9709.

Please act quickly and send your letters and make your calls. Thanks for your attention to this most pressing issue facing NYSSA and the clubs.
